

DOG CATCHING CLAIM EXAMPLE FOR XE21 (Example 1)

Salem to Laclede (Train), Laclede to Salem (Taxi), Salem to St Peter (Taxi), St Peter to Salem (Train), Salem to Kell (Taxi), Kell to Salem (Train).

You want to claim total miles ran on your tie up then press F12 (Available Claims):

1. Put a X in “Dog Catch out of limits” (Kinmundy to Laclede and return to Kinmundy) You will need to give the time out of limits (The time you spend from Kinmundy to your Laclede and return to Kinmundy) in this case 00:30 (30 min.) then it will ask for the times 11:45 to 12:15. Then you can give a brief explanation of what you did.
2. Put a X in “Leaving terminal after 8 hours” (Your 2nd trip will get you over 100 miles) (They say we are to use this claim for the 2nd trip out violation) (Article 4.k If your first trip is over 25 miles the 2nd trip out of your home terminal is considered a new day, if the 1st trip was less than 25 miles out but the 2nd trip out put you over 100 miles for the day, then the 2nd trip is considered a new day). Fill it out as prompted.
3. Put a X in “Leaving terminal after 8 hours” (You Left your terminal after being on duty 8 hours) Fill it out as prompted.
4. Put a X in “Dog Catch out of limits” (Salem south) You will need to give the time out of limits (The time you spend from Salem south and arrival back at Salem) in this case 02:29 (2 hr 29 min.) then it will ask for the times 18:01 to 20:30. Then you can give a brief explanation of what you did.

6. Fill out a Non Service Slip for “Running through terminal” You went north and got your train and took it through the terminal when you went south.

Please drop a note in my box telling me you went both north then south (This would be a mishandled time slip for the 1st out Engineer on the XE01 when you left Salem going north)

NOTE: Your FRA report needs to be filled out correctly in order for your claims to be paid. (I'm sure some claims will be turned down, we will need to handle them through the normal claim handling process.)

DOG CATCHING CLAIM EXAMPLE FOR XE01 (Example 1)

**Salem to Bush (Taxi), Bush to Salem (Train), 2nd trip out Salem to MP275 (Taxi)
MP275 to Salem (Train).**

You want to claim total miles ran on your tie up then press F12 (Available Claims):

1. Put a X in “Dog Catch out of limits” You will need to give the time out of limits (The time you spend from MP 303 to your destination and return to MP 303) in this case 01:00 (1 hour) then it will ask for the times 09:30 to 10:30. Then you can give a brief explanation of what you done.

2. Put a X in “Leaving terminal after 8 hours” (They say we are to use this claim for the 2nd trip out violation (Article 4.k If your first trip is over 25 miles the 2nd trip out of your home terminal is considered a new day, if the 1st trip was less than 25 miles out but the 2nd trip out put you over 100 miles for the day, then the 2nd trip is considered a new day). Fill it out as prompted.

NOTE: Your FRA report needs to be filled out correctly in order for your claims to be paid. (I’m sure some claims will be turned down, we will need to handle them through the normal claim handling process.)

DOG CATCHING CLAIM EXAMPLE FOR XE01 (Example 2)

Salem to Bush-Taxi, Bush to Laclede (Train), Laclede to Salem, 2nd trip out Salem to Kell (Taxi), Kell to Salem (Train).

You want to claim total miles ran on your tie up then press F12 (Available Claims):

1. Put a X in “Dog Catch out of limits” (MP 303 to Bush and return) You will need to give the time out of limits (The time you spend from MP 303 to your destination and return to MP 303) in this case 00:30 (30 min.) then it will ask for the times 15:45 to 16:15. Then you can give a brief explanation of what you did.
2. Put a X in “Dog Catch out of limits” (Salem north, off your assignment) You will need to give the time out of limits (The time you spend from Salem to your destination and return to Salem) in this case 02:00 (2 hours) then it will ask for the times 19:00 to 21:00. Then you can give a brief explanation of what you did.
3. Put a X in “Leaving terminal after 8 hours” (Your first trip was over 25 miles) (They say we are to use this claim for the 2nd trip out violation (Article 4.k If your first trip is over 25 miles the 2nd trip out of your home terminal is considered a new day, if the 1st trip was less than 25 miles out but the 2nd trip out put you over 100 miles for the day, then the 2nd trip is considered a new day). Fill it out as prompted.
4. Fill out a Non Service Slip for “Running through terminal” You went south and got your train and took it through the terminal when you went north.

Please drop a note in my box telling me you went both south then north (This would be a mishandled time slip for the 1st out Engineer on the XE21 when you left Salem going north)

NOTE: Your FRA report needs to be filled out correctly in order for your claims to be paid. (I'm sure some claims will be turned down, we will need to handle them through the normal claim handling process.)
